In consideration of being allowed to participate in any way in Rocket Pro Wrestling Company athletic sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,

I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Rocket Pro Wrestling Company their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

Rocket Stars Code of Conduct and Standards

PLEASE READ CAREFULLY – SIGNATURE REQUIRED.

WRESTLER & SPECTATOR SAFETY

- Please do not use the barricades in your match. The barricades are there for your protection from the crowd and the crowd's protection from you. They are not there to enhance your match.
- **ABSOLUTELY no wrestling into the crowd!** The barricades are the boundary by which you must conduct any match. There are too many families in the crowd to venture or perform outside the designated area. Any injury or subsequent issues occurring to a spectator is subject to liability on your behalf. RPW reserves the right to halt or otherwise prevent any match from proceeding or continuing if RPW, in its sole discretion, opts to so halt or prevent such match. **A violation of this rule shall result in your being ejected from the venue and a forfeit of any consideration to be paid by RPW to you.**
- In the event a **Rocket Star** wishes to perform something potentially, difficult or dangerous, an accommodation can be made provided you speak with RPW management about what you intend to do, and PRIOR approval is given.
- Work safe, and be a conscientious **Rocket Star!** There is no reason for anyone to get hurt – our events are for entertainment purposes only. Do not be reckless.
- Absolutely no unattended children before, during, or after the event. If you bring children to the event, you must exit them as soon as the event is over with the rest of the spectators.
- It is strongly encouraged and welcomed if wrestlers, characters, and staff assist with take-down. Putting chairs and the wrestling ring away, in particular.
- RPW asks that children not be present during take-down. RPW is not responsible for any injury to any child at setup, during the event itself, or take-down. It is the responsibility of their guardians to ensure their safety.

BEHAVIOR

- **Swearing/cursing in the ring or during an event will not be tolerated.** RPW reserved the right to terminate any match at any point due to inappropriate behavior or use of foul language. RPW's **Rocket Stars** don't speak that way. Try to keep it clean, professional and entertaining – it's a family event.
- Since it is part of offering excitement to spectators, "high-fiving" during your entrance is acceptable, but do not touch spectators in any other way before, during, or after your match. RPW has special needs spectators and they may misinterpret your actions.
- During an event we are recognized by our spectators as **RPW Rocket Stars**, so wrestlers are discouraged from socializing within the crowd or with any fans during an event.
- **No smoking in front of the building.** You have a character to portray and we don't want to take away from that so, smoking is permitted **ONLY OUTSIDE** in the back of the park.

PUBLIC ADMISSION & FEES

- All front row seating is currently \$25.00.*
- General admission seating is currently \$20.00.*
- Children 4 years of age, and under, are free.
- Free admission to those wrestlers or characters only on the match card.
- If you bring a guest with you, the guest pays the general admission price unless they desire the front row – then front row price applies. **There is no "plus one" offered by RPW to wrestlers or characters.**

BACKSTAGE ETIQUETTE

- If you are not on the card, you do not get backstage. NO EXCEPTIONS.
- If you are not a member of the staff, you do not get backstage. NO EXCEPTIONS.
- Please clean up after yourself. Don't leave water bottles, wrappers, gym bags (and the like) laying around. Keep the space clean and safe for yourself, and for others to work.
- **DO NOT STAND BEHIND THE CURTAIN OPENING AT ANY TIME**, especially during other **Rocket Stars'** entrances. Show respect for your fellow wrestlers.
- Please do your best to keep quiet backstage once the doors open, during entrances. We can be heard in the arena from behind the fabric curtain wall. Non-descript noises distract from the event itself. Be discreet at all times.

MERCHANDISE

- If you are selling your own merchandise, you can sell during intermission and / or bring a representative to sell for you.
- If you have someone selling your merchandise, they must pay the \$20.00 general admission fee.
- We do not charge a "table fee" for the use of merchandise sales.

RPW RIGHTS & RESERVATIONS

- In consideration of your participation in any RPW event, you hereby give us the right to use you image or stage name in our promotional, marketing and merchandising materials such as photography, videotape or recordings for any and all parts of each event and retains the rights for its own purposes in perpetuity and throughout the universe.
